A) The “Funding for the Oxford Global Law Society” Financial Motion

Proposer: Hannah Fareed

Seconded: Amelia Jolly

This JCR notes that:

- The Oxford Global Law Society (OGLS) is one of Oxford’s fastest-growing and most ambitious student organisations, providing a platform for students to engage with international law, human rights, and global justice.
- Founded in 2025, OGLS stands apart from other law societies through its intellectual rigour -- it is the only society at Oxford that approaches the law as a discipline of theory and practice, not just as a career route.

- c. Within its first year, OGLS has hosted or confirmed internationally renowned speakers including: Dr Mark Ellis, Executive Director of the International Bar Association, involved in the Saddam Hussein trial and post-conflict justice in Yugoslavia and Ukraine; Sara Wahedi, TIME Next Generation Leader and Forbes 30 Under 30 honouree; Harj Narulla, barrister who represented the Solomon Islands in the ICJ climate change advisory opinion; Martha Minow, former Dean of Harvard Law School.
- d. The OGLS Networking Access Scheme connects students of all backgrounds to global legal leaders through dinners, receptions, and coffee meetings -- giving Oxford students access to advice, insight, and mentoring that would otherwise be out of reach.
- e. OGLS offers free general membership to ensure accessibility, with an optional £10 lifetime membership that provides access to premium small-group networking opportunities, reserved seating at flagship events, and one-on-one mentorship sessions.
- f. External sponsorship from law firms is limited due to the society's intellectual and ethical commitments. Many firms seek to "buy" events to promote their brand or recruitment schemes, which contradicts OGLS's intentional focus on critiquing, questioning, and understanding legal systems rather than marketing them.
- g. All funds raised go directly towards event costs and subsidising student access -- not administrative overheads This JCR believes that: (Why the JCR should fund your project - does it contain JCR members, does it have a positive message, will the project struggle for funds without JCR support?)
- h. The work of OGLS aligns with the college's core values of access, intellectual excellence, and global engagement.
- i. Many members of this JCR could directly benefit from OGLS events -- not only law students, but also those studying PPE, History, Biology, and related disciplines.
- j. Supporting OGLS demonstrates the JCR's commitment to fostering inclusive, academically rigorous student initiatives that make a tangible contribution to Oxford's intellectual and social life.
- k. A contribution from the JCR would make a tangible difference to the society's ability to host world-class events and make them accessible to all Oxford students, including those from this college.

This JCR therefore resolves to: (What do you propose we do?)

- a. Give £200 to the Oxford Global Law Society for the subsidisation of student access and event costs from the Financial Motions Budget
- b. Require a written report from the Proposer, to be uploaded to the News section on the JCR website.

C) The “Funding the Oxford Coffeehouse Society” Financial Motion

Proposer: Luna Holden

Seconded: Ebrahim Jadama

This JCR notes that: *(Details about the project that needs funding)*

- (overview of the society) The Coffeehouse Society is inspired by the development of coffeehouses as hubs of literary, musical and artistic expression and sharing in the Ottoman Society. While we're inspired and interested in MENA culture, language and history this society our events have highlighted culture, history and science from across the globe.
- The Oxford Coffeehouse is a cultural society, however in comparison to the other cultural societies in Oxford (which are mainly catered to students who are native to a specific culture) we emphasise cross-cultural communication and celebrate the idea of being a global citizen. We also welcome and encourage our members to learn from different cultures and get out of their comfort zone.
- Moreover, we are an interdisciplinary society that hosts academic events, rather than just social events, on subjects ranging from Arabic romance, Bangladeshi cultural clothing identity to the ancient medicine of Egypt. While it may be common to think that culture simply means literature, history and language etc. we recognise the value of also recognising the scientific achievements of different countries throughout history and work with STEM societies and students to deliver events on equally fascinating events on maths, medicine and astronomy.
- Moreover, we are a society that prides itself on platforming student voices. While we do invite guest speakers, we think it is important that students from this university can hold events on subjects that interest them allowing them to practice their skills as well as meet like-minded people. Finally, The Coffeehouse Society is a society focused on unity and

education, inspired by how a single drink brought people from different walks of life together to learn from each other and share their knowledge.

- e. (what need funding) As we are the Coffeehouse society, we would like to offer our members food and drink (coffee/tea, snacks, and very occasional dinners) as it is in our ethos that these two aspects are essential to building community and bringing people together.

This JCR believes that: *(Why the JCR should fund your project - does it contain JCR members, does it have a positive message, will the project struggle for funds without JCR support?)*

- a. The proposer (Luna Holden) and seconder (Ebrahim Jadama) of this motion are JCR members and many of our society members are JCR members as well.
- b. We are a new society that wants to spread knowledge of different cultures in a welcoming and inclusive environment and want to give the opportunity to student to share what they learn here during their studies.
- c. Many of our events are at St John's and honour the legacy of this college's history of Middle Eastern Studies since the Professorship in Arabic was established by William Laud in 1611.
- d. Our membership is free, and we want the majority of our events to be free because we believe that knowledge and community should not be kept behind a paywall. We as students ourselves from low-income backgrounds, understand that even small amounts for event tickets can pile up and we want our members to enjoy quality events without having to worry about their budgets.

- a. Give £150 to "The Oxford Coffeehouse Society" from the Financial Motions Budget
- b. Require a written report from the Proposer, to be uploaded to the News section on the JCR website

D) The “Funding the Oxford Arabist Magazine” Financial Motion

Proposer: Luna Holden

Seconded: Ebrahim Jadama

This JCR notes that: *(Details about the project that needs funding)*

- (brief overview of project) Oxford Arabist Magazine is a new and the first student-run blog based in the University of Oxford that covers news, articles and essays on the Middle East and North Africa region. The magazine founders are all Oxford Arabic students who want to express their creativity and interests of MENA outside of their Oxford curriculum. We have so far provided a platform for student voices, our project has become popular not only amongst Arabic students but those of Arabic heritage who are happy to see their culture celebrated.
- (what needs funding) We want to print our first edition and hold a launch party to spread the news of our magazine, give people physical copies and celebrate our launch. The amount we are asking would include printing costs and design costs for 100 copies and go towards food and drink at the launch party.

This JCR believes that: *(Why the JCR should fund your project - does it contain JCR members, does it have a positive message, will the project struggle for funds without JCR support?)*

- There are three JCR members involved in this project, besides me (Luna Holden), there is Ebrahim Jadama and Adam Rashid Thomas.
- Our message is to celebrate and give voice to students studying Arabic/have an interest in the MENA region and we want to create a positive, insightful and educational community in Oxford about MENA.

This JCR therefore resolves to: *(What do you propose we do?)*

- Give £200 to The Oxford Arabist from the Financial Motions Budget [/Kendrew Arts Fund]
- Require a written report from the Proposer, to be uploaded to the News section on the JCR website

Luna:

- Large sum, but open to amendment
- Open to anyone interested in MENA
- Platform to voice student interests in the region and to publicise articles
- Would represent a good chance for CV improvement and for students to practice skills outside of teaching
- Good chance to freely student beyond the university curriculum in the MENA area
- Funds are for printing first editions, a launch party, and advertisement

Jerome:

- Friendly amendment to £150?
- Long term funding plan?

- Luna: reliant on launch party – sponsors want to see more of what ‘we can do’

E) The “Clarification of Accommodation for Suspended Students” Constitutional Motion

Proposer: Mia Clark-Webb

Seconded: Neos Tang

This JCR notes that:

- a. The current situation for students returning from their suspension is not particularly clear in the JCR’s Constitution.
- b. It is suggested by the Constitution that suspended students may enter the Finalist Ballot again if they were never in residence in their room from the Finalist Ballot, but that this could be dependent on negotiations with the Vice President.

This JCR believes that:

- c. Preparing to return from suspension can be a very stressful process, especially if the suspension was due to health conditions.
- d. Therefore, the entitlement to re-enter the Finalist Ballot should be automatic (provided they never took residence in their previous Finalist Ballot room), and should not depend on any negotiation with the Vice President.
- e. If a suspended student took residence in a Finalist Ballot room for only a term before suspending due to health problems, it would be unfair to penalise them for this.

This JCR therefore resolves to:

- f. Replace, in Standing Order Table Six, §7(2)(a.) “No member may appear on the Finalist Ballot more than once.” with “No member may appear on the Finalist Ballot more than once, unless they are returning from suspended status and occupied a room from the Finalist Ballot for no more than 12 weeks.”
- g. Delete, in Standing Order Table Six, §9(a.) “§7(2)(a.) of this Table may only be waived if the member suspended such that they did not occupy the room they gained from the Finalist Ballot previously for a full academic year.”

Mia:

- Room ballot process unclear for students who have suspended and returning as finalists
- Motion is to reword the constitution to make this clear for returning suspended students who have only been in their finalist room for one term

Joe:

- Seems very sensible; seems unfair to punish someone for suspending

F) The ‘Help Fund It Happens Here – Oxford’s Anti Sexual Violence’ Financial Motion

Proposer: Ben Smith

Seconded: Lillia Goldstein

This JCR notes that:

- a. It Happens Here is valuable and important society for Oxford students with multiple registered members from St John's.
- b. Previously funded by the SU, but following its disbandment of student campaigns, IHH are now operating independently and have lost funding.
- c. IHH is in the process of applying for a society grant but this will not be awarded in the coming weeks.
- d. IHH is asking other colleges and Oxford based charities, companies, and organisations for support with funding. There has been no success in the latter.
- e. Sexual violence is prevalent across all colleges and thus St John's students would benefit from the work that we do.

This JCR believes that:

- a. Financial support would thus greatly benefit IHH in its early stages as an independent society.
- b. Funding would allow us to put on our Still I Write event which is our most well attended termly event offering a community space for survivors and allies. This event helps to keep the campaign visible for students who need it.

This JCR therefore resolves to:

- a. Give £150 from the Financial Motions Budget to help us hire The Nest on Little Clarendon Street for Still I Write.

Ben:

- Anti-sexual violence society, invited the president to speak on the society's behalf

President of It Happens Here:

- Used to be funded by the SU but now operating independently
- Asking for funding to re-start before we get fully registered again
- Need funding for regularly termly event (Still I Write) - open mic poetry to enhance visibility
 - o Need to pay to rent venue
- Going to ask Sommerville and Hughs as well, but former has faced cuts and latter might only provide \$50

G) The "JCR Officers" Constitutional Motion

Proposer: Jerome Pailing

Seconded: Ruth Magedera

This JCR notes that: *(Facts about the current situation/constitution)*

- a. The JCR exists to improve student life as much as possible, providing welfare support, academic assistance, and social events wherever possible
- b. Therefore we should have a set up of officers and reps designed to maximise what students can gain from the JCR
- c. As a JCR, we should also be engaging with charities more, running more events for charity and collaborating more with the wider Oxford community, meaning we should have a dedicated Charities Officer for this purpose

This JCR believes that:

- a. I propose to introduce the possibility for 3 people to run for Entz Officers (as well as the initial 3) so that workload can be spread (therefore replacing the more minor Entz reps), to re-allocate the Entz side of the External Affairs role (formal swaps and college collabs) to Entz Officers, the academic side (careers talks etc) to the Academic Affairs Officer, the alumni relations to the President, which is already the situation, and liaising with external charities to the new Charities Officer, and liaising with external businesses to the Publicity Officer, replacing the External Affairs Officer
- b. I propose to introduce a Charities Officer, whose job it would be to liaise with and promote external charities, and run fundraising events in college
- c. Other than that, there are a couple of changes to clear up the constitution to reflect reality (multiple facilities reps, no appendices to the constitution)

This JCR therefore resolves to: *(What do you propose we do?)*

- a. Replace Article 23.a “Domestic Officers and Entertainment Officers, which must be occupied by two people, and if one or both resign, the procedure in Standing Order Table 3B shall be followed.” with Article 23.a “Domestic Officers, which must be occupied by two people, and if one or both resign, the procedure in Standing Order Table 3B shall be followed.” and Article 23.b “Entertainment Officers, which must be occupied by two or three people, and if any or all of them resign, the procedure in Standing Order Table 3B shall be followed.”
- b. Remove Standing Order Table Two §2.k “The External Affairs Officer”
- c. Remove Standing Order Table Two §4.k “Entz Rep(s)”
- d. Replace in Standing Order Table Two §2.h.V (Entz Officers) “Set up and tidy up all events, assisted by the Entz Reps and the JCR General Committee when required.” with “Set up and tidy up all events, assisted by the JCR General Committee when required.”
- e. Remove Standing Order Table Two §2.h.VI (Entz Officers) “Shall be responsible for, shall fill in for and shall meet at least once per term with Entz Reps.”
- f. Add, in Standing Order Table Two §2.e.V (Academic Affairs Officer) “Shall arrange careers talks from alumni each term, from a broad range of fields”, VI “Shall liaise with the Oxford Careers Service and organise careers guidance sessions”
- g. Add, in Standing Order Table Two §2.h.VI (Entz Officers) “Shall endeavour to have at least one social partnered with other JCRs each term, including bops and formal swaps”
- h. Add, in Standing Order Table Two, §2.s The Charities Officer:

- h. Shall be responsible for liaising with and promoting external charities in the Oxford area and beyond
 - h. Shall work with the treasurer to manage the Charities Budget
 - h. Shall organise at least one fundraising event each term
- i. Amend Standing Order Table Three A:
 - i. Change 2b. to:
 - i. 2. b. Candidates for the position of Domestic Officers must run in pairs.
 - i. Add, after 2. b., 2. c.,
 - i. 2. c. Candidates for the position of Entertainment Officers must run in pairs.
- j. Amend Standing Order Table Three B and C as such:
 - j. For an Officer position which must be occupied by multiple people (under a subsection of §23) and they must all run together (under Standing Order Table 3A §2b.-c.), and either 1c. or 1e. occur, or 1d. occurs with all Officers not in residence for the following academic year, then a by-election is held for the role.
 - i. Candidates for the replacement must run in groups of the sizes permitted by Standing Order Table 3A §2b.-c..
 - ii. The Officer(s) still in office remain in office until the time at which the new Officers start holding office under §19.
 - j. If, for such a role that must be filled by between n and m , $2 \leq n \leq m$ people, 1d. occurs with k Officers $k \geq 1$, remaining in residence for the following academic year, then the Returning Officer shall ask the remaining Officer(s) which of the following they wish to occur, and shall hold a by-election (or not) as requested:
 - i. A by-election is held, to be filled by at least one and between $n - k$ and $m - k$ people, to join the remaining Officer(s). If $n - k \geq 2$, then candidates in this by-election must run in groups.
 - ii. A by-election is held for the role as a whole, to be filled by between n and m people, running together, to replace all the Officers.
 - iii. No by-election is held: the remaining Officer(s) hold(s) the role for that Michaelmas, potentially with less than n Officers in the role.
- k. Replace, in Articles 22, 24 and Standing Order Table Two 3.c, "Facilities Rep" with "Facilities Rep(s)"
- l. Remove in Articles 1, 4, 48, references to "Appendices"
 - l. Amend §21 to:
 - i. Remove "External Affairs Officer"
 - ii. Add "Charities Officer" (at the appropriate alphabetical position of non-exec Officers)
 - l. Amend §22 to:
 - i. Remove "Entz Rep(s)"
- m. Remove references to Appendices in the following places:
 - m. Standing Order Table 2:
 - i. §2a. II.
 - ii. §2c. VII

- iii. §2c. IX (which should be removed outright)
- m. Standing Order Table 7§7a

H) The “Publicity Officer” Constitutional Motion

Proposer: Jerome Pailing

Seconded: Leanne Mabena

This JCR notes that: *(Facts about the current situation/constitution)*

- a. The way JCRs function has changed a lot in the past few years (post-Covid, the current social media climate etc)
- b. Social media is a major form of outreach for JCRs trying to form part of the city community, and the dominant way of interacting with the college community and signposting different events (physical noticeboards for posters are less important now than twenty years ago)

This JCR believes that: *(Why the situation/constitution should be changed)*

- a. We should bring more emphasis on a digital JCR’s outreach by upgrading the role of JCR Social Media “reps” to one “officer”
- b. This creates more accountability for social media (meetings with president every term), rewards the hard work which already goes into our social media output, and allows us to have a more cohesive JCR digital strategy and team (combined with the launch of our new website last month)

This JCR therefore resolves to: *(What do you propose we do?)*

- a. Add Publicity Officer to §21 in the appropriate position
- b. Remove from §22 "Social Media Reps"
- c. Replace Standing Order Table Two, §2b.VII (Vice President) “Shall be responsible for, shall fill in for and shall meet at least once per term with Facilities Reps, Stash Reps and Social Media Reps.” with “Shall be responsible for, shall fill in for Facilities Reps and Stash Reps.”
- d. Add, in Standing Order Table Two, §2.r The Publicity Officer:
 - I. Shall manage the JCR Instagram Account, ensuring that content appropriate to both current and prospective students is updated regularly.
 - II. Shall promote the JCR’s activities to a wide range of stakeholders, including but not limited to prospective students and alumni.

- III. Shall co-ordinate with other JCR officers to advertise JCR elections, meetings, events and post introductions to officers.
- IV. Work with JCR Sub-Committees, including but not exclusive to the Freshers' Week Committee, Arts Week Committee and the Ball Committee to promote their activities.
- V. Shall liaise and collaborate with external organisations and other colleges' JCRs as necessary.
- VI. Should manage all other social media accounts held by the JCR ensuring appropriate content provision, with the exception of the JCR Facebook group and the JCR website.

I) The "Help Fund A View From the Bridge!" Financial Motion

- a. **Rohan Joshi** and **Nicole Palka** are members of the **SJC** JCR, and are both in the cast of the production, intended to run at The Oxford Playhouse, Week 4 of Michaelmas Term.
- b. The **£70** grant from the SJC JCR is vitally important for assistance with the overall production costs. Without this the production cannot successfully go ahead.
